Note:

- Asbestos samples at Station 14 (West Face - South end at corner [scaffolding level]), Station 15 (South Face - East end at corner [scaffolding level]), Station 16 (East Face - North end at corner [scaffolding level]), and Station 17 (North Face - West end at corner [scaffolding level]) on March 5 and 6, 2007 were not available for analysis. Strong winds made the scaffolding stations inaccessible.
- Asbestos samples at Station 14 (West Face - South end at corner [scaffolding level]), Station 15 (South Face - East end at corner [scaffolding level]), Station 16 (East Face - North end at corner [scaffolding level]), and Station 17 (North Face - West end at corner [scaffolding level]) on March 7, 2007 were not available for analysis. Snow and ice on the scaffolding made the stations inaccessible.
