- --delete each of 1.1(B), 1.1(C), 1.1(G), 1.1(P) and 1.1(Q).

- --delete the last sentence of 1.1(M) beginning "Where indicated . . ."
- --in 1.1(R), restate as follows: "'Notice to Proceed' means that upon execution by LMDC and Contractor of this Contract, Contractor will be authorized to begin Work. No actual separate notice from LMDC shall be required."

- --in 1.3(D), restate as follows: "Water Service: Pay water service use charges for water used by all entities for deconstruction operations. 2" Water Riser is installed thru the 22 nd floor with a hose bib attachment available at each floor."

--in Part 3(A)(1), change "Base Bid" to "Lump Sum".

Section 01595:

- --in 1.1(A), change "Demolition Contract Clauses" to "Contract Documents"
- --in 1.2(A) change "Contracting Officer" to "LMDC"
- --delete existing text in 2.2 and refer to Annex 6.
